1. Call to Order

Chairman Jorritsma called the meeting to order at 10:00 a.m.

2. Roll Call

Chairman Jorritsma noted that there three members of the Watermaster were present. Paul Toor of the City of Banning was late.

3. Pledge of Allegiance.

Chairman Jorritsma led everyone in the Pledge of Allegiance.

4. Oral and Written Communication

Chairman Jorritsma asked if there were any written or oral communications for the meeting. One communication from the South Mesa Water Company was received. George Jorritsma of the South Mesa Water Company indicated that the water company had 3,000 acre-feet of stored groundwater for sale for \$140/acre-foot.

5. Consent Calendar

Motion by Member Zoba, second by Member Butcher, and by unanimous vote:

Moved to approve the consent calendar as presented.

6. Action Items

A. Approval to Recapture Water in Storage for Watermaster Fiscal Year 2005/06 - Beaumont Cherry Valley Water District

Chief Schlange indicated that the application was in the agenda package. Beaumont Cherry Valley Water District requested to recapture 822.9 acre-feet of water in their groundwater storage account.

Motion by Member Zoba, second by Member Butcher, and by unanimous vote:

Moved to approve application as presented.

B. Approval for Recharge – Beaumont Cherry Valley Water District

Chief Schlange indicated that the recharge application was in the agenda package. Beaumont Cherry Valley Water District requested to recharge 9,500 acre-feet of State Water Project water pursuant to their groundwater storage agreement.

Mr. Davis said they estimate 60% of the allocated 8,650 acre-feet of State Water Project (SWP) water for the San Gorgonio Pass area water will be received. Mr. Davis indicated that staffing for the pump station is currently low and 24-hour staffing is being attempted. Mr. Davis further stated that capacity should not be an issue and he anticipates that the San Gorgonio Pass Water Agency will be able to meet all requests for SWP water for the 2007 calendar year.

Motion by Member Butcher, second by Member Toor, and by unanimous vote:

Moved to approve the application for recharge as presented.

7. Reports and Updates

A. Draft Third Annual Report of the Beaumont Basin Watermaster

Ms. Davis presented the Draft Third Annual Report of the Beaumont Basin Watermaster and noted the changes from the second annual report. Member Butcher questioned the production numbers for Beaumont Cherry Valley Water District and indicated that he would verify the numbers with his staff. Mr. Wildermuth stated that a method to transfer overlying water rights needs to be developed.

B. Progress Report on Subsidence Investigation Update (Verbal Presentation)

Mr. Wildermuth reported on the status of the subsidence investigation. Mr. Wildermuth reviewed the historical subsidence investigation. A network of new benchmarks was installed in November 2006 and the first survey was conducted. The next survey will be performed in April 2007. A final report will be submitted to the state after the April 2007 survey. Mr. Wildermuth recommended that the benchmark survey be conducted every year for the next five years and that the In SAR data be acquired and analyzed in the fifth year.

C. Progress Report on Septic Investigation in Beaumont Management Zone (Verbal Presentation)

Ms. Davis presented the groundwater model simulations of future impacts to the Beaumont Basin from discharge from on-site waste disposal systems (OSWDS). Three model scenarios were presented: no sewer system in the Cherry Valley Community of Interest (CVCOI) and no recharge at the BCVWD Recharge Facility; no sewer system in the CVCOI; and the CVCOI has a sewer system operable by 2011. Dramatic improvements in water quality were observed with the removal of OSWDS.

D. Progress Report on Salt Mitigation Fee Evaluation for the Beaumont Management Zone (Verbal Presentation)

Mr. McCarthy presented a progress report on the salt mitigation fee evaluation. Mr. McCarthy reviewed the process for characterizing the salt loading to the Beaumont Management Zone from each party and from each source. Preliminary results were presented and next step in the process was outlined.

E. Progress Report on Groundwater Level Monitoring Program (Verbal Presentation)

Ms. Davis reported that ten pressure transducers were installed in the Beaumont Basin.

F. Progress Report on the BCVWD Recharge Project (Verbal Presentation)

Mr. Harder presented a progress report on the BCVWD Recharge Project. Geosciences is using pressure transducers to monitor the change in water levels at the recharge facility and to estimate the travel time for the recharge water to percolate to groundwater.

G. Accounting for Supplemental Water Recharge (Verbal Presentation)

Mr. Wildermuth reported that forms need to be developed to account for supplemental water recharge. The Watermaster Rules and Regulations will need to be modified as necessary.

H. Progress Report on the Regional Resource Optimization Program Scoping Work for Fiscal 2006/07 (Verbal Presentation)

Mr. Wildermuth presented an outline of the Regional Resource Optimization Program Report and discussed the progress made to date.

8. Status Reports

A. Watermaster Committee Member Comments

There were no comments from the Watermaster committee members.

9. Adjournment

There being no other business, Chairman Jorritsma adjourned the Watermaster meeting at approximately 11:15am.

RE: Revision to Task Order 6 Upper Limit

Dear Mr. Schlange:

This letter explains the effort expended to date to implement the Special Groundwater Level Monitoring Program in the Beaumont Basin, and is a request to increase the task order upper limit from \$25,000 to \$31,000.

This monitoring program originally involved the installation of data-logging pressure transducers at 10 production wells distributed across Beaumont Basin. To perform this work, about 25 wells were canvassed to choose appropriate 10 candidates. Water level time series charts were created for each well to understand the normal water level fluctuations in each well. "Dummy" transducers were installed at each well to see if a transducer could be inserted to the appropriate depth, and then extracted for data download and transducer maintenance. This process took longer than expected because of several factors, such as difficulty gaining access to well sites and/or difficulty in inserting and extracting the "dummy" transducers. Many more wells were visited that originally planned for.

After transducer installation, field staff returns to the wells to extract the transducer and download the data to check for proper installation and transducer function. A number of transducers were not functioning properly. Additional time was spent coordinating with the transducer vendor (In-Situ, Inc.) to exchange/repair the failed transducers, and then re-install and test the new transducers.

As a result of unanticipated additional work, we are requesting that Watermaster increase the task order upper limit from \$25,000 to \$31,000.

Dear Jeff:

During the period July 1, 2003 through June 30, 2006, the San Gorgonio Pass Water Agency (Agency) recharged approximately 2150 acre-ft at the boundary of the Beaumont Basin as defined in the Beaumont Basin Stipulated Agreement. The Agency, as of this writing has initiated recharge at these same facilities and plans to do so for at least part of the remaining fiscal year (through June 30, 2007). The water used for recharge comes from the Agency's State Water Project (SWP) allocation and is intended to address the Agency's perceived overdraft in the Beaumont Storage Unit, which has boundaries that are identical to the Beaumont Basin as defined in the Beaumont Basin Stipulated Agreement. Pursuant the stipulated agreement, SWP water is defined to be Supplemental Water. The Agency is not a party to the stipulated agreement but did participate in the negotiations that led up to the development of the stipulated agreement.

The pertinent citations from the stipulation that are related to the Agency's storing of supplemental water in the Beaumont Basin include:

"Any Supplemental Water stored in the Beaumont Basin, except pursuant to a Groundwater Storage Agreement, shall be deemed abandoned and not classified as Stored Water." (II.2., Page 7)

"This Judgment, and the Physical Solution decreed herein, address all Production and Storage within the Beauty ont Basin." (V.3., Page 14)

"Any Person cake reasonable beneficial use of the Groundwater Storage Capacity for storage of Supplemental Water: provided, however, that no such use shall be made except pursuant to a written Groundwater Storage Agreement with the Watermaster." (V.5.b., Page 15)

This letter is an invitation to the Agency to submit an application to the Beaumont Basin Watermaster for a Groundwater Storage Agreement in which the Agency can place the water that it has already recharged or plans to recharge in the Beaumont Basin. This invitation must be submitted to the Beaumont Basin Watermaster Chief of Watermaster Services by May 14, 2007. Upon receipt of this application, Watermaster staff will prepare the necessary staff analysis and report and submit it to the Watermaster for approval at its June 13, 2007 meeting. To aid in the application process, we have attached a partially filled out application for the Agency to use. The Agency needs to fill in the amount

of storage requested by the Agency, affix a signature, and submit it to the Chief of Watermaster Services.

Should the Agency fail to submit an application by May 14, 2007, the Watermaster may, pursuant to the stipulated agreement, declare all of the Supplemental Water recharged by the Agency through June 30, 2007 abandoned and allocate this water to the appropriator parties for their subsequent use.
