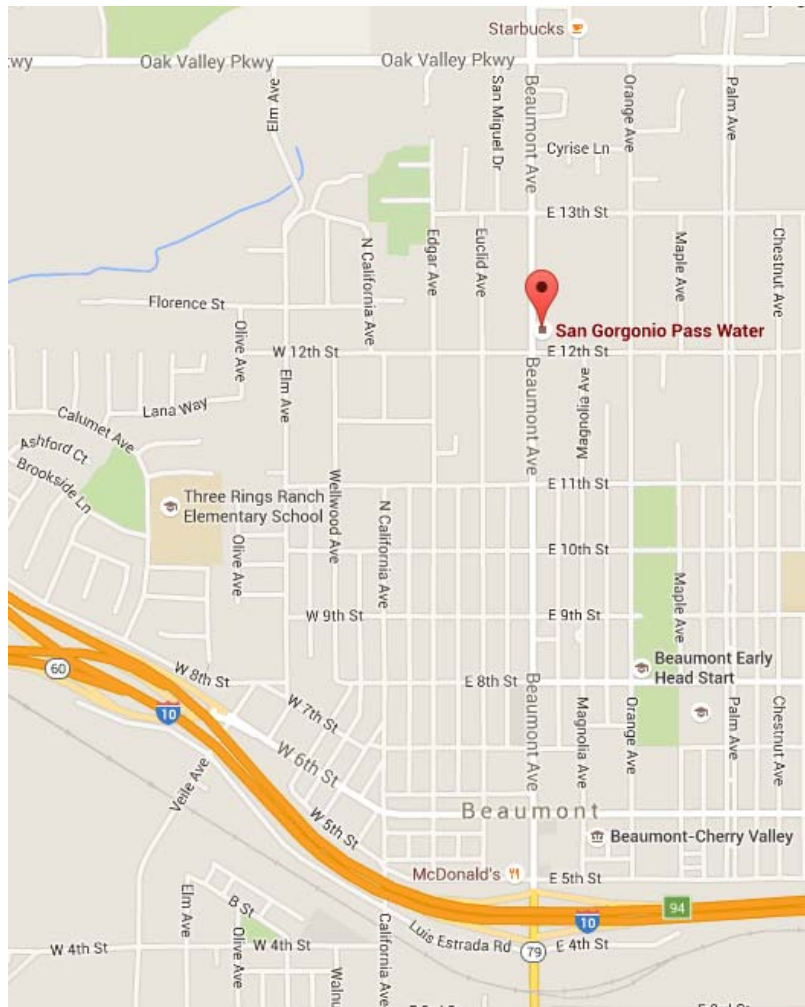

You are invited to a special allocation workshop to be hosted by the San Geronio Pass Water Agency on Tuesday, May 10 at 4:00 pm in the Agency's Boardroom.
