Government Code Section 53235 requires local government officials (members of a legislative body) who receive any type of compensation or reimbursement for expenses to receive at least two hours of ethics training every two years.

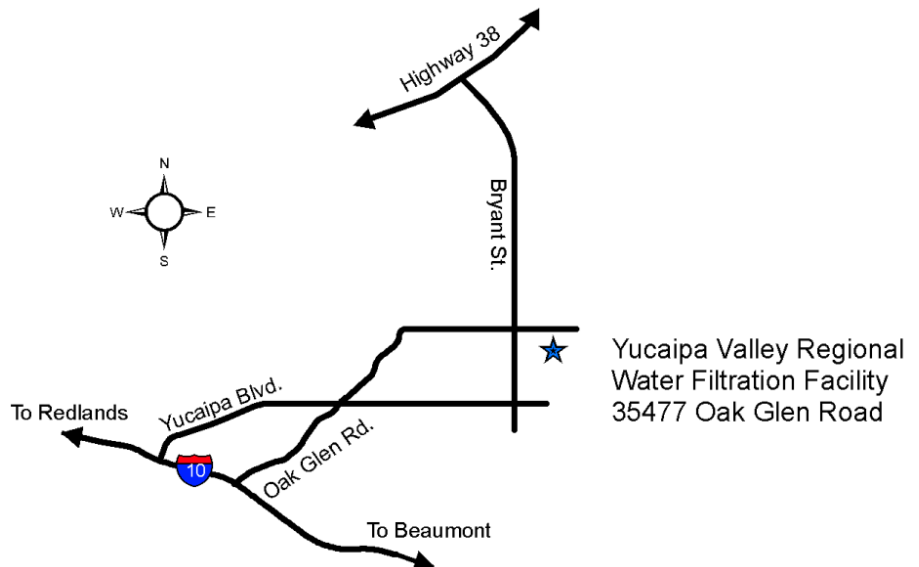
To fulfill the requirements of this legislation, the Yucaipa Valley Water District will be sponsoring a free Ethics Training Program on **Thursday, January 19, 2017 at 6:00 p.m.** The two hour program will be held at the Yucaipa Valley Regional Water Filtration Facility located at 35477 Oak Glen Road, Yucaipa.
