BOIL WATER NOTICE

BOIL YOUR WATER BEFORE USING

IVY AVENUE (PARTIAL), LIANA STREET, CHERRY CROFT DRIVE,
KEVARI COURT, CAROL DRIVE, HOPE LANE, HOLLY STREET,
JEFFERSON STREET (PARTIAL), JOCELYN LANE (PARTIAL)
Failure to follow this advisory could result in stomach or intestinal illness.

Due to the planned water infrastructure repair, the State Water Resources Control Board, Division of Drinking Water in conjunction with the San Bernardino County Health Department, and the Yucaipa Valley Water District, as a precautionary measure, are advising residents on the **streets listed above** to use boiled tap water or bottled water for drinking and cooking purposes as a safety precaution.

DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST. Bring all water to a boil, **let it boil for one (1) minute**, and let it cool before using, or use bottled water. Boiled or bottled water should be used for drinking and food preparation **until further notice**. This is the preferred method to assure that the water is safe to drink.

Service interruption will begin at approximately **8 PM Monday December 11, 2017**. We will inform you when tests show that water is safe to drink and you no longer need to boil your water. We anticipate resolving the problem within the next two days.
