Board Meeting - April 28, 2021 - 10:00 a.m. - - Online Meeting - -

On March 4, 2020, Governor Gavin Newsom declared a State of Emergency resulting from the threat of COVID-19 and issued Executive Order N-25-20 (3-12-20) and Executive Order N-29-20 (3-17-20) which temporarily suspend portions of the Brown Act relative to conducting public meetings. Subsequent thereto, Governor Newsom issued Executive Order N-33-20 (3-19- 20) ordering all individuals to stay at home or at their place of residence. Steve Stuart discussed the development of Management Areas based on existing geological structures, distribution of groundwater wells, and groundwater

dependent ecosystems. The proposed Management Areas will each have individual sustainability criteria to monitor and avoid undesirable results.

Mark Iverson moved to adopt the proposed Management Areas identified as the North Bench Management Area, Western Heights Management Area, San Timoteo Management Area, and Calimesa Management Area.

1. Consider Sustainability Criteria and Projected Conditions for the Western Heights, North Bench, Calimesa, and San Timoteo Management Areas

Steve Stuart discussed the need to set sustainability criteria for each of the Management Areas to prevent significant and unreasonable effects associated with the operation of the groundwater basins. The sustainability criteria would include two measurable objectives established at (1) the historical low in groundwater level and (2) a 30% to 60% loss in well field production. The proposed minimum threshold would be established as an undesirable result of more than 70% loss in well field production or a significant loss in groundwater dependent ecosystems.

The meeting participants discussed alternative approaches to setting measurable objectives for each of the Management Areas.

Steve Stuart stated that he would review the information and prepare an alternative approach to the creation of measurable objectives.

2. Discussion of the Proposed Management Actions

Steve Stuart presented conceptual management actions that will be refined and presented at a future meeting.

D. Discussion of Draft Chapters 1, 2, and 3 of the Groundwater Sustainability Plan

Comments have been received from South Mesa Water Company and the City of Yucaipa. Additional comments should be provided through the SharePoint site.

E. Status Update on Draft Chapter 4 Projects and Management Actions

Steve Stuart reported that Chapter 4 is planned to be released in May 2021.

F. Discussion of the First Annual Report for the Sustainable Groundwater Management Agency








Yucaipa-SGMADRAFT – SUBJECT TO REVISIONWells Used to Develop Calimesa Management AreaSustainability Criteria




Calimesa Management Area Sustainability Criteria







DRAFT – SUBJECT TO REVISION Wells Used to Develop Western Heights Management Area Sustainability Criteria




Western Heights Management Area Sustainability Criteria




Western Heights Management Area – Sustainability Criteria




Vucaipa-SGMADRAFT – SUBJECT TO REVISIONWells Used to Develop North Bench Management AreaSustainability Criteria



North Bench Management Area Sustainability Criteria






Sustainability Criteria in San Timoteo Management Area

Confirm Sustainability Criteria

✓ Confirm Goals of Sustainability Criteria

✓ Minimum Threshold

 Undesirable results – 15% to 20% loss in storage from current condition; loss in GDEs



Proposed Management Actions

- Administrative Fees cover costs of annual administration of Yucaipa-SGMA
- 2. Replenishment Obligations
 - a. Deliver imported water to management area where groundwater extracted
 - b. Deliver imported water to management area upstream of where groundwater extracted
 - c. Deliver water to filtration facility as in lieu recharge
- 3. Water Loss Replenishment Fee replenish 5% of total groundwater extracted



Proposed Management Actions

- 4. Sustainable Yield Replenishment Fee
 - a. replenish 5% of water extracted from a management area.
- 5. Excess Extraction Replenishment Fee
 - a. A 1:1 volume replenishment of water extracted in excess of the sustainable yield.
 - b. May be offset if water retailer added water to storage from prior year spreading.




