- IV. Discussion Items
 - A. Consideration of Resolution 2022-01 Authorizing the San Bernardino Valley Municipal Water District, a member of the Yucaipa Sustainable Groundwater Management Agency, to act on behalf of the Agency to prepare an application for the Sustainable Groundwater Management Grant Program SGMA Round 2 Implementation Grant and to enter into a funding agreement with DWR to receive a grant for the Yucaipa Subbasin Groundwater Sustainability Plan Phase 1 Implementation

Steve Stuart presented information about the Round 2 Sustainable Groundwater Management Implementation Grants available for projects that would benefit the Yucaipa Basin. The deadline for submitting a grant application was changed from November 30, 2022 to December 16, 2022. In order to submit the grant application, the Board will need to adopt Resolution No. 2022-01 to authorize the San Bernardino Valley Municipal Water District to act on behalf of the Yucaipa Sustainable Groundwater Management Agency.

Lance Eckhart moved to adopt Resolution No. 2022-01. Tim Green seconded the motion.

Joseph Zoba moved to prioritize the County Line Road Turnout and Recharge Basin as Priority 1 and the Salinity and Groundwater Enhancement (SAGE) Project as Priority 2. Lance Eckhart seconded the motion.

Marina Magana mentioned that the maximum grant application is for \$20 million so there is a possibility that both projects might receive funding if the grant is successful.

There was a general consensus by the board members to include about \$50,000 in administrative costs as part of the grant funding request.
